Entries Eligibility:

Every affiliated unit will be eligible for Two Singles & One Doubles & One Mixed Doubles .Host District will be eligible for two additional singles & one doubles & one Mixed Doubles

However, all the affiliated units can send additional entries on payment of prescribed fee.

-Rs . 800/-for Singles

-Rs 1500/- for Doubles (per pair)

Entry Fee for additional entries must be deposited to the host district before the start of the championship. Once the draws are displayed, players have to pay the entry fee.
